18/2013 Public Forum.

Q. Why wasn't the planning application for the Solar Farm more widely advertised?

A. The application was more widely advertised within the village than usual with extra posters and public meetings.

19/2013 Chairman's report.

- Telegraph poles are being replaced on Upper Green Road.
- Bembridge and St Helens Harbour Association meet this Saturday the 16th March.
- Nomination packs for anyone wishing to become a Parish Councillor are now available from either the Clerk or Clive Joynes at County Hall. The closing date for applications is the 5th April.
- The election affects the Parish Council meetings and from the 26th March the Council must operate under electoral regulations and therefore must not discuss or decide on any matters

that may give anyone a political platform. Therefore the April meeting will be for urgent procedural business only and no debates will be entered into.

20/2013 To discuss and approve the 'Licence to Occupy' the toilet block on St Helens Green.

Councillor Bacon reported that he had been in discussions with the IW Councils solicitors regarding the Licence to Occupy for the toilet block on the Green. The contract stated that the Parish Council would be responsible for "other impositions" as this term has not been defined on the license it has been referred back to the IW Council for a full list of what "other impositions" may be or for the term to be removed from the license.

Cllr Bacon proposed that the Parish Council wait until a revised license is received and discuss again at the next meeting.

Councillors confirmed that they had all read the policy and were happy with its content.

22/2013 To agree budget for Laptop purchase.

The clerk reported that the laptop was not working properly and crashing frequently. Due to the battery being exhausted the laptop regularly overheated and shut down. She had had it looked at and was told that it was not powerful enough to operate modern programmes and this was also contributing to the problem.

Mrs Parsons proposed that £600 be allocated for the purchase of a new laptop and professional software.

23/2013 To discuss and agree projects and expenditure for any volunteer projects.

The Clerk reminded Councillors that at the last meeting they had suggested that volunteers be recruited for village projects as they had voted against hiring an Environment warden/litter picker. £1500 was allocated in the budget for that role but that money was now able to be used to increase reserves or fund some projects for volunteers. The Chairman invited ideas for projects from Councillors.

Ideas included.

- Beach clean.
- Improvements to Horseshoe Trail
- Replacing the posts on the Old Church Green.
- Bench repairs.

Cllr Bacon proposed that £500 be allocated in the budget to cover any expenditure incurred by volunteer projects.

Clerks report March 2013

- External Audit Fees have been reduced as new auditors have been appointed. New Cost will be £100.
