Mr Anderson raised

• That there are still abandoned cars in the car park.

The clerk assured him that they had been reported and that some had been issued with tickets and some had already been moved.

- The memorial shelter needs painting.
- Goal posts need painting.

Mr Dyer raised

- Holes in the R86 Mill Wall Clerk assured him that this had been reported and chased as it was unclear initially who was responsible for the maintenance. Island Rds are now looking into it.
- R88 Gaggen Edge. The bridge is in a poor state of repair.

Mr Williams raised

- Would like the Cricket poles removed at the end of every match not the end of the season.
- Posts have not removed from outside the pavilion as the IW Council promised.
- The posts on the West Green are too far from the Boundary and traffic is now using nd parking on that section of Green outside the posts.
- The hedge by Boundary Oaks on Carpenters Road that borders the West Green is now so overgrown that it has taken 30 40 foot off of the West Green, the property appears to have removed their boundary fence and claimed some of the Green.

Mr Wade reported

- Potholes on Field Lane.
- He was unsure if the habitual and Vexatious complaint policy applies as he has reported this matter before. The Chair assured him that the policy would come into force for persistent unreasonable complainants and not for matters such as these.

The meeting was attended by a number of local young people who wished to request the Parish Council support them with their aim of having a skate park installed within the village. They requested help with identifying suitable land and securing funding. It was suggested that the school should be approached to see if they had land that could be used.

76/2013 To receive an update on the Economic Improvement Grant works.

The clerk reported that the new benches had been erected and notice board installed and that the posts and chain works were due to start shortly.

She reported that she was still waiting to hear from Island Roads regarding whether there are any limitations on the size of bin they will empty and whether they will empty bespoke bins.

77/2013 St Helens Green

a, to receive a report from the Chair regarding the meeting about the Green with the Parks Manager at County Hall.

The Chair, Clerk and Cllr Bacon met Alex Minns and John Metcalfe from the IW Council to discuss some issues with the management of the Greens.

- The issues discussed included problems with parking and lack of enforcement.
- Abandoned vehicles
- The legal status of the car park
- Fly-tipping

It was agreed that the legal team would look into the options open to them regarding enforcement of parking regulations, bye-laws and the legal status of the car park. A further meeting is to be arranged once they have researched these further.

b, To discuss issues regarding St Helens Green arising from the report.

The Chair allowed both Councillors and members of the public to air their concerns.

These concerns included:

- Rubbish dumping on the horseshoe trail and car park.
- Water run off from a blocked off well.
- Erosion of the Green.
- Tree stumps by Sheepstar Cottage.
- Parking outside of the Well House.

78/2013 To receive an update/report from the Carnival Committee.

Councillor Bacon reported that all was well with the Carnival Committee although the recent fundraising events had been unsuccessful. They had, however, managed to secure a grant for £300 to help towards costs.

He appealed for help on the Carnival day (August Bank Holiday) as there will be a lot to set up and take down.

Cllr Bacon also reported that the garage where the Village Fayre and Carnival equipment is stored will be unavailable from the 1st Sept. He said he was happy to continue storing the equipment but it would have to be outside under a tarpaulin or similar as he no longer had the space to store the equipment.

79/2013 Clerks report.

The Clerk reported that:

- there has been some confusion over who takes responsibility for the holes in the Mill Wall, due
 to it being maintained by both the IW Council and Island Roads. They have been chased to
 ensure something is done quickly.
- There is £522.21 left remaining from the Economic Improvement Grant, which match funded gives the Parish Council £1044.21 to spend.
- Bins this weekend were overflowing on the Duver and Old Church Green.
- Abandoned cars in Car park have been looked into and enforcement action will be taken where necessary.
- Have received complaints about the increasing amount of stones on the beach, can something be done?
