Traffic matters - concerns with vehicles at speed in Field Lane & further requests for a crossing at bottom of Broomfield Close. Traffic items will be on next month's agenda.

#### 32-23/24 CLERK'S REPORT

Report of an encouraging meeting with the manager of Nodes Point, hoping to establish a good working partnership. Items discussed daily litter picks on Church Green, drainage, future plans of the park.

Priory Footpath - question over ownership of the footpath after another incident - not clear who the land belongs to where the incidents are happening. Clerk to source information & signs if appropriate.

Council rerouted the footpath a couple of years ago. Can the Council re route the footpath again? Clerk to ask.

Vine Road drain - fixed - but a report of a leak further down Vine Road. Tarmac is lifting and seeping into the drain. Clerk to report to Island Roads.

IOWC - parking charges are to be increased from 30.6.23

Reports of Caravans overnight - enforcement - report all details to the IOWC.

LCWIP - plan has been given approval - which is a positive move for future grant applications.

A suggestion has been put forward for St Helens and Bembridge to fund a waste bin at either end of a bridleway from Bembridge to St Helens and for both councils to share the cost.
